1. TASA Grant

- The LHAI team is working on the final designs of the curb ramps and the storm sewer system upgrades. We will be meeting with Tom Keffer this Friday to review the new curb bump outs (CDBG funding) in the field. After this meeting, we will forward an updated plan to Penn DOT depicting the TASA work plus the curb bump outs and the flashing cross walk lights per Penn DOT's request.

2. DCNR Grant – Park

- Construction is complete. Application for Payment No. 3-FINAL should be paid upon completion of the finished grading and re-seeding.
- I have reached out to Columbia Excavating, the site contractor, to perform touch up grading and re-seed along the exterior of the perimeter timbers. Columbia Excavating is to perform the re-grading work this Friday.
