

July 27, 2020 Planning Workshop Committee Meeting Minutes

Call to Order @ 6:30 p.m. Planning Workshop Committee Meetings are advertised as performing general business.

Roll Call – In attendance; *Rick Kline, Tyler Longenecker, Don Raiger, Tom Keefer, Joan Keefer, Robin Wolferd, Mayor Quairoli & Jeff Schott.*

New Business – Discussion was opened in regard to crack filling & curb sealing on various roads in the borough. **A motion was made by Rick Kline, seconded by Don Raiger, to approve having D.B. Krieg perform the crack filling and curb sealing on the identified roads in the borough, not to exceed \$17,000; paid from the General Fund. Motion carried.** Mayor Quairoli abstained from discussion, as a conflict of interest.

Rick Kline updated council on amending the DGS Statewide Road Salt Contract; requirement of 75 tons in the 2020-2021 season instead of 150 tons. Discussion followed. **A motion was made by Rick Kline, seconded by Jeff Schott, to approve amending the DGS Statewide Salt Contract for the 2020 – 2021 season from 150 tons to 75 tons. Motion carried.**

Request council ratify the email approval to extend the green waste permits purchased in 2020 as valid through 12/31/2021. **A motion was made by Don Raiger, seconded by Robin Wolferd, to ratify the email approval to extend the green waste permits purchased in 2020 as valid through 12/31/2021. Motion carried.**

Rick Kline requested approval to have the bobcat serviced, at a cost not to exceed \$1,000; paid from the General Fund. **A motion was made by Tyler Longenecker, seconded by Rick Kline, to approve having the bobcat serviced, at a cost not to exceed \$1,000; paid from the General Fund. Motion carried.**

Old Business – A request was made to approve Leb-E-Free Church (J-Rock) perform their community service event (8/7 & 8/8), & free family carnival (8/9 @ 4:30 p.m.) on Aug. 8th, 9th & 10th, 2020. Discussion followed. Tyler Longenecker will be meeting in the park tomorrow evening to discuss projects with the J-Rock volunteer committee members. **A motion was made by Tyler Longenecker, seconded by Jeff Schott, to approve Leb-E-Free Church (J-Rock) to perform their community service event (8/7 & 8/8), & free family carnival (8/9 @ 4:30 p.m.) on Aug. 8th, 9th & 10th, 2020; contingent upon relevant waivers (signed) & insurance certificates received. Motion carried.**

Mayor Quairoli opened discussion on the following, recent activities & issues at the Boat Launch:

- Agreement w/ Fish & Boat Commission
- No Swimming
- No alcoholic beverages
- Closing boat launch area
- Enforcement
- Displaying launch permits on parked vehicles
- Barricades placed at the entrance

Mayor Quairoli will contact the police requesting assistance on enforcement, check on agreement with Fish & Boat Commission, displaying a launch permit, status of sign ordered & contact Attorney Gallo for recommendation on parking & other restrictions.

Jeff Schott opened discussion in regard to having a handicap parking space policy versus an ordinance. Discussion followed. A decision was made to refer to Colleen Gallo for recommendations at council meeting. Jeff will send an email to Colleen Gallo before the next council meeting.

Rick Kline requested approval to rent a line painting equipment. **A motion was made by Rick Kline, seconded by Tyler Longenecker, to approve renting line painting equipment, to paint lines on the roads, at \$150/day; not to exceed \$500, paid from the General Fund. Motion carried.**

Tom Keefer opened discussion on spraying weeds along borough streets. Joe Quairoli volunteered to spray weeds along the curbs in Twin Creeks, Lancaster St. and Market St.

Upon motion and second, Council adjourned at 8:00 p.m.
